(Immediately following Physical Mtg. beginning at 6:30)**

The meeting was called to order at 6:58pm by Chairwoman Addonizio who requested Legislator Ellner lead in the Pledge of Allegiance. Upon roll call Legislators Ellner, Gouldman and Chairwoman Addonizio were present.

**Item #3 – Acceptance of Minutes – August 16, 2023 & Budget Meeting October 11, 2023**

The minutes were accepted as submitted.

**Item #4 – Approval/ Resolution Requesting Governor Hochul to Sign A250A/S01466, Authorizing Payments to Nonparticipating or Nonpreferred Providers of Ambulance Services Licensed Under Article 30 of the Public Health Law/ Legislator Montgomery**

Chairwoman Addonizio stated Legislator Montgomery requested that this resolution be brought forward. She thanked Legislative Counsel Robert Firriolo for drafting this resolution. She read the resolution into the record.

Legislator Jonke questioned if County Executive Byrne is supportive of this resolution.

Legislative Counsel Firriolo stated the County Executive was not consulted when drafting the resolution, but when it is in front of him to sign he has the option to veto it if he does not agree.

Legislator Jonke stated he understands Legislator Montgomery is unable to be here this evening to speak to this. He stated he would have liked a representative from the Bureau of Emergency Services present to address this.

Legislative Counsel Firriolo clarified that to draft this resolution he reviewed the bill and sponsors' memorandum of explanation and incorporated that into the resolution at the request of Legislator Montgomery. He stated the draft resolution is not an expression of an opinion on the merits of it.

Legislator Sayegh stated she believes this topic was briefly discussed previously. She questioned the legality of the company keeping the payment.

Legislative Counsel Firriolo stated if the ambulance company is not on the list of preferred providers for the insurance company, they will not be paid by the insurance company.

Legislator Ellner stated when the contracts were being redone with the ambulance providers it was clear there had been a change in the State law to prevent the local ambulance companies from billing direct. He stated he does not see how this addresses that problem. He stated Deputy County Executive James Burpoe is present and is familiar with this process and asked for his input.

Deputy County Executive Burpoe stated Legislator Ellner's statement is correct, the ambulance companies were not allowed to bill.

Legislator Nacerino stated she sits on the Fire Advisory Board and recouping fees and receiving payment is an issue. She stated her support for this resolution. She stated Legislator Ellner's concern may be a separate issue.

Legislator Ellner questioned if the State bills will allow the ambulance companies to bill.

Legislative Counsel Firriolo stated this resolution is addressing the situation where the ambulance company is not a preferred provider and the insurance company is paying the patient directly. He stated the ambulance company would then have to chase the patient to try to get reimbursed.

Chairwoman Addonizio stated she believes there are two (2) separate issues, this resolution addresses one (1).

Chairwoman Addonizio made a motion to pre-file the necessary resolution; Seconded by Legislator Gouldman. Legislator Ellner abstained. Motion carries.

Chairwoman Addonizio thanked the volunteers on all the boards and stated her appreciation for their time.
